# **Privacy Policy**



**Willetton Podiatry** ("we", "our", "us") safeguards the privacy of your personal and health information in accordance with the Privacy Act 1988 (Cth) and its cornerstone, the Australian Privacy Principles (APPs). This Privacy Policy outlines how we manage your information.

### **Definitions**

- *Personal information* means information or opinions about a person from which that person is reasonably identifiable. Personal information may include sensitive information such as information about a person's health.
- *Health information* is a subset of personal information or opinions about a person's health. It includes information collected in connection with the delivery of health services.

## **What Personal Information We Collect**

We collect information necessary for providing quality podiatry care, including:

- Personal details: full name, date of birth, address, email, phone number, Medicare/private health insurance details.
- Health information: medical history, diagnoses, referrals, treatment plans, prescriptions, pathology/imaging results, and progress notes.
- Billing and administrative data: appointment history, billing information, payment method, and claim details.

#### **How We Collect Your Information**

We collect personal information:

- Directly from you (eg: forms, consultations, phone, email, online bookings).
- From other health professionals with your consent (eg: GPs, specialists).
- Through our website and third-party systems (with consent).

# Why We Collect and Use Your Information

Your information is accessed by relevant practice staff members to:

- Deliver effective podiatry services.
- Maintain accurate health records.
- Communicate with other health professionals as required.
- Manage billing and health insurance claims.
- Comply with legal obligations (eg: public health reporting).
- Improve services, including client feedback and audits.
- Communicate with you for purposes including, but not limited to, appointment reminders, responding to queries, provision of accounts and marketing.

# **Storage and Security of Information**

Your information may be stored at our clinic in the form of paper and/or digital records. Cliniko, our practice software, is a privacy-compliant, cloud-based system hosted in Australia. They employ strong encryption, regular backups, and access control to protect your information. They do not review, share, distribute, or reference any customer data.

We also maintain safeguards, including password protection and staff confidentiality protocols.
